SECTION 4 — FIRST AID MEASURES

Immediately call a POISON CENTER or physician (P310).

If inhaled: Remove victim to fresh air in a position comfortable for breathing (P304+P340).**If in eyes:** Rinse cautiously with water for several minutes.
